Fund Raising Progress for Information to Our Esteemed Members.

Let me begin by saying, this is not an one-man mission or a select group or a forum who's involved in this effort of Fund Raising. It's been an earnest effort of various committees, Varied Interested Members of our club in various capacities have liasioned directly or indirectly and helped us connect in good faith to raise the required funds in helping us build The Koramangala Club as one of the best and happening club in the city of Bengaluru if not the country.

Our earlier correspondence mailers and brochures mailed to you will be the dream project! The effort is not just a elected group of representatives but a lot of guardian angels who have stepped forward in making the project a reality! They sure, will be recognised one fine day with honour and respect!

Following is a brief runner of the process for the information of our members.

Talks have been on with Rotary Club of Koramangala and IIT Alumni to become donors of small meeting halls with a little added benefits for a period of 15 years for a sum of Rs. 20 lacs each totaling to Rs. 40 lakhs.

Prestige Builders, one of the premium builders having their headquarters at Bangalore and of national fame have come forward in sponsoring the Reception Lounge branding for 10 years for a sum of Rs. 20 lacs. They have promised further support in engaging with the club activities. Negotiations are in process for bulk Residential Membership of 100 or more in S.T. bed apartments with a concession of Rs.1 Lakh. Prestige would be willing to partner with our club in all activities and growth time to time.

Accell Partners who are immediate neighbours of our club has taken 16 Corporate Memberships, has promised Rs.1 crore towards building fund In turn they would require 20 parking slots in the club premises and 30 car passes to be utilised between 10 am and 5 pm on working days. They are further envisaging Corporate Membership and would like to recommend other fellow corporates. We also offer 30 room nights per annum for 10years and 20 sessions will be given per annum for 10 years in the Auditorium F & B will be paid.

Diageo and Kingfisher are in talks for certain association to establish mixed bar and Ground floor bar like Kingfisher.

Nani's Nook associated to Le Concierges and one of our club Member's Mrs. Dipali Sikand has offered to be associated with us. Our club members can also avail facilities of the afore said organisation. Which are having about 300 + clubs affiliations. The induction of members is as per TKC bye-laws.
